
MINUTES FROM THE REGULAR MEETING OF JULY 15, 2015

- **1. CALL TO ORDER.** The meeting was called to order at 4:50 at the Mohawk Community Center in Blairsden, California. Present were John, Don, Don Jr., J.D, and Glenn.
- **2. APPROVAL OF AGENDA.** Approval of the Agenda was moved by Don Jr. and seconded by Don. All present approved the Agenda.
- **3. APPROVAL OF MINUTES.** Approval of the Minutes from the May 20 meeting was moved by Don and seconded by J.D. All present approved the minutes. Minutes from the June 17 meeting were not available, but will be reviewed for approval at the August 19 meeting.

- **7.1 Fourth of July.** Glenn reported the Groomer entry in the parade was well received, that had set up a kiosk using a picture board of the refurbishment of the Old Maintenance Building and a pair of long board skis, that he and John talked to a number of people that came to the kiosk, and he had collected \$164.05 in donations and 14 names of people willing to be volunteers and/or make donations.

Glenn agreed to assemble volunteers to help improve the area. Tom Connolly volunteered to secure a brush cutting machine. Don Jr. volunteered the Ski Club to pay for the cost of renting the brush cutting machine.
- **7.3 Restrooms.** The Committee discussed different approaches to the improvement of the restrooms including portable toilets, a design based on portable toilets, a vault system as well as the current system. John volunteered to get more information about programs and designs promoted our authorized by the California Department of Parks and Recreation.
